#### **Introductory comments**

- Chair welcomed members and introduced and thanked new members for attending
- PPG reiterated that they represent the patient population and bring anonymous concerns to this forum to be addressed
- Minutes from the last meeting approved and uploaded to practice website

## Matters outstanding from the last meeting

- Issues with the number of online appointments available (and therefore ability for patients to book online), S Parmar said this number is low due to the number of patients who do not attend prebooked appoints (DNAs), therefore currently only 3% of all bookable appointments are offered online. Patients are sent texts about DNAs to remind them that failure to attend affects other patients and the service that can be provided by the practice

- Discussion on recruitment and retention S Karia inquired about retaining staff members before leaving the practice, S Parmar said they do all they can to retain staff but that some turnover is normal for all GP practices
